2021 OKC Futurity Horse Sale Consignment Contract



I hereby consign the foregoing livestock (the "Animals") to OKC Barrel Futurity, LLC. (OBF) for sale in the 2021 OKC Futurity Horse Sale (the "Sale") to be included in the Sale catalog subject to the following Terms and Conditions:

- I warrant title to each Animal free from all adverse claims to ownership, use or possession, and agree to defend title against all claims. I authorize OBF to advertise and sell each animal at public auction, to make the representation and warranties set forth in the Sale Catalog on my behalf, to deliver possession of each Animal to the highest recognized bidder, to transfer title thereto, and to receive and disburse the proceeds of sale from my account.
- I agree to pay OBF the designated Entry Fee on or before the due date and agree that the Entry Fee will be deemed earned by OBF on that date. I understand that the Entry Fees and Conditions of Acceptance to the Sale are as follows: Sale Entry Fee is \$350, plus a Sales Commission of 7% (for sale) and a Sales Commission of 4% (for repurchase) of the final recognized bid; with a minimum commission of \$200 for repurchase. After entry is made, there shall be no substitutions. There shall be no refund of entry fee after the deadline unless a licensed veterinarian determines that the animal is unfit for sale due to injury or illness or death. Upon receipt of the veterinarian's written statement, the OBF will then consider a refund not to exceed \$200. I understand that the aforementioned Entry Fee(s) covers the cost of stalls, stall signs, pedigree analysis, and handling of entries prior to the Sale. I understand expenses incurred by OBF through the sale or attempted sale of the animal(s) will be my responsibility, and I authorize OBF to deduct all sums owing to OBF from my account and in the event of any deficiency, I agree to immediately pay OBF the balance due.
- I understand that OBF reserves the right to: (i) reject the entry of any Animal in the Sale at any time; (ii) approve any assignment of my rights and obligations under this agreement; (iii) determine the order of sale of all Animals; (iv) assign stabling facilities subject to such stabling policies as OBF may establish; (v) examine each Animal and make such catalog corrections and announcements as OBF deems appropriate; (vi) reject Animal if Animal is not in saleable condition on Date of Sale, retaining entire Entry Fee, and (vii) change the time, date, or location of the Sale should circumstances, in OBF's sole discretion, necessitate such change(s).
- I agree prior to entry deadline to deliver to OBF the following documents for each entry: a) CERTIFICATE OF REGISTRATION ; b) completed and signed AQHA TRANSFER REPORT and; c) completed, signed and dated CONSIGNOR'S CONTRACT for each entry. Check your Registration Certificate for accuracy. If inaccuracies are found after Sale Inspectors compare the animal with the Certificate a "Corrected Certificate" must be prepared by the Sale office, an administrative fee of \$200 to cover AQHA charges and postage and handling costs will be assessed.
- I agree to deliver to the Sales office upon arrival at the sale the following documents as prescribed below: No animal will be sold unless all required documents are on file in the Sales Office prior to the auction. a) A negative COGGINS TEST dated no earlier than six months prior to Sale date- due upon arrival. b) A licensed Veterinarian's HEALTH CERTIFICATE issued within 14 days of the Sale Date.
- I understand that all necessary documents regarding sale of the Animal must be in possession of OBF prior to Sale in order to receive Net Proceeds from the sale of my Animal. Net Proceeds will be distributed NO EARLIER THAN TEN (10) BUSINESS DAYS AFTER DATE OF SALE. I understand that proceeds will not be distributed on any Animal that is subject of a dispute or claim by purchaser until such dispute or claim is resolved and the proceeds of sale have been received by the OBF. I understand that I am not entitled to any interest or monetary compensation for any such delay in the distribution of Net Proceeds.
- I agree to provide such information as OBF might request with respect to the ownership, description, pedigree, parentage verification, produce, performance, health and conformation of each Animal, and I AGREE TO REVIEW SALE CATALOG AND PROMPTLY NOTIFY OBF OF ANY CORRECTIONS THERETO. I understand that I am the sole guarantor of all information regarding my Animal(s) in Sale Catalog and that neither OBF nor the Sale Catalog Production Company employed by OBF will be held responsible for errors in documentation of Sale Catalog.
- I represent and warrant to the buyer and to the OBF the following: a) Title to the Animal free from all adverse claims to ownership, use, or possession; b) The Animal is sound of eyes and mouth; c) The Animal is not a "Cribber"; d) The sex and condition as a stallion, gelding, or ridgeling, of the Animal is as described in the Sale Catalog; e) The Animal is not afflicted with Locomotor Ataxia (Wobbler Syndrome); f) That I will disclose any Invasive Surgery(s) that the animal has had and provide a veterinarian's certification that the animal has suffered no ill effects from such surgery. g) That the animal has never been administered any Exogenous Anabolic Steroids. I understand that I AM REQUIRED TO INFORM OBF OF ANY SUCH AFOREMENTIONED

PHYSICAL CONDITIONS AT TIME OF ENTRY FOR INCLUSION IN THE CATALOG OR ANY CONDITION OCCURRING AFTER ENTRY AS AN ANNOUNCEMENT AT THE SALE or face purchaser's possible refusal of Animal and forfeiture of my Entry Fee and Sale Proceeds.

- I agree to deliver each Animal F.O.B. to the Sale location no later than 12:00 pm (noon) on the day prior to the sale. I understand that the maintenance of each Animal is my responsibility until sold, and I agree to care for each Animal while stabled on the Sale premises in accordance with OBF's husbandry and stabling policies. On my failure to so care for any Animal, I agree that OBF may, at OBF's option, undertake such care, and I agree to reimburse OBF for all expenses of stabling, feed, veterinarian care, transportation, and maintenance of Animal. I agree that OBF will not incur any liability whatsoever for the loss, damage, injury, death or illness of any Animal.
- I understand that OBF will use reasonable efforts to verify the financial responsibility of the Buyer of each Animal, and that possession of each Animal will be released to the buyer against receipt of future payment after satisfaction of OBF's Settlement Procedures. I agree that if the sale of any Animal is not consummated by reason of the default of the buyer or otherwise, OBF shall not be liable for the purchase price of the Animal and OBF's sole obligation shall be to assist me in the collection of the purchase price of the Animal, recovery of the Animal or resale of the Animal at the Sale or by private sale to the extent that I might request. I understand that OBF does not guarantee the validity, enforceability, payment or collection of any instrument delivered to OBF in payment of the purchase price of any Animal. Any obligation which OBF might owe to me by reason of a buyer's default will be discharged by OBF's resale of the Animal by public or private sale, whether or not the resale price equals the price agreed to be paid by the defaulting buyer.
- I agree to indemnify and hold OBF and Better Barrel Races, LLC, harmless from all claims, expenses and costs (including without limitation, attorney's fees) arising out of: a) Any question of title to or my authority to sell any Animal; b) Any lien, attachment or claim asserted against any Animal or the proceeds of Sale; c) Any claimed default in my representations or warranties with respect to any Animal; d) Loss of damage to property and injury or death of persons caused directly or indirectly by me, my agents, or employees, or any animal; e) My entry or sale of any Animal; f) Any questions of parentage of Animal or any failure of the Animal to verify its parentage as represented herein and in the Sale Catalog; g) My default in performance hereunder; I AGREE TO PAY OBF, ON DEMAND, THE FULL AMOUNT OF ANY LOSS WHICH OBF MAY INCUR IN SETTLEMENT OF ANY CLAIM OR DEMAND ON ACCOUNT THEREOF.
- I understand that the terms of the Sale Conditions and Settlement Procedures published in the Sale Catalog will govern the sale of each Animal, as will the laws of the State wherein the Sale is held, and I hereby approve the same and agree to be bound thereby. I understand that should any provision of OBF's contract be held illegal, such illegality or invalidity shall not affect the remaining provisions of the Contract.
- This Contract is binding on me, my heirs, personal representatives, successors, permitted Assigns, any successor in ownership of each Animal, and will inure to the benefit of OBF's successors and assigns. Any person signing this agreement will be jointly and severally liable for the upholding of these Conditions. I have read the foregoing terms and conditions, and upon signing this Contract, agree to abide by them.
